

## Always follow your last order!

On Saturday 3<sup>rd</sup> November 1984, I was scheduled to work on the Ashford P.S.U (late turn policing to the Kent Coal Fields) Our Sergeant was PS Bob Pollard!

Also on that day, there was a bit of a 'Posh Wedding' taking place in Ashford, whereby the Queen would be attending. The bride was the eldest daughter of Lord and Lady Brabourne, who lived nearby at Mersham. Lady Brabourne being a relative of her majesty.

It was decided that our P.S.U would not be going to the pits, but would instead 'Police' the wedding.

The reception was to be held at the Caldecott Community Centre in Mersham, part of the Brabourne Estate. I was sent to the reception area early in the shift to generally police the area.

Access to the reception for the wedding party and guests was to be via a longish private driveway, which led into the reception area. It was going to be dark when the party arrived, therefore the area was to be illuminated by portable lights.

I was then briefed along with 3-4 others PCs by the Chief Inspector in charge. We were told to let the first 6 vehicles through as it would be the bride and groom and immediate family. After that we were to stop-check all other motors and to advise them where to park.

The motors started to arrive, 1,2,3,4,5,6 motors passed by and I stepped forward and started to wave my torch and held up my hand, signalling the driver to stop.

It was clear to me the car had no intention of stopping. I kept waving my torch and raising my hand in a 'stopping motion' but motor no 7 kept coming closer and closer, at the last second I jumped out of the way – whoosh!! I thought the driver must be blind given the rather large headlights on the car!



Not too long after, the Chief Inspector appeared, he wasn't very happy.

He asked which one of us had tried to stop the Queens car!

All of a sudden I was left standing there on my own as the others had slunk off. "It was me sir" I said "You told us to let the first 6 cars through, then start stopping and checking the rest, but car no 7 wouldn't stop for me." I was then made aware that car no 7 was in fact her majesty's vehicle.

"Is that why it had no number plates sir?" I questioned.

We did not leave the venue until after midnight and arriving back at Ashford nick probably after 1am. The Chief Supt and Supt decided to open the bar, with everyone leaving around 3am.

PS. A few years later, a retired traffic PC told me he was the driver of the Queens car on that day (he was based at T4 which was at Ashford Police Station for those of you who didn't know). He told me he had seen me signalling for him to stop, but the bodyguard sat next to him told him to keep driving. He basically told him to run me over if I didn't move. The PC kept saying under his breath "Bob get out of the way".

Extracts from emails from Chris Collins.

Dear All

I have today spoken to Head of Payroll and Pensions, who as always was extremely helpful. As a matter of interest there is a weekly meeting with XPS to raise any issues, so keep me updated if any of you are having problems, and I can collate for them.

I have to say from evidence thus far NARPO (Police Pensioners) do not appear to have any problems with XPS or logging on and creating their own personal account.

#### The telephone number for XPS is 0330 054 5552.

There is one matter I forgot to mention when we chatted earlier and that relates to the death of a Police Pensioner and the notification to XPS of that death. They have just completed a booklet for pensioners and their families as to what to do in the event of a death, obviously it was previously a process with KCC, and obviously we wanted to know what to do now with XPS.

Kent Police have taken a digital first approach. Historically paper payslips were sent only when there was a net pay of +/-£5.

Unfortunately there was a data breach with another force and this resulted in the Payroll team investigating a more secure solution than post. As a result the decision was made to only provide email payslips, and Pensioners were informed of this in May 2023. The member portal allows member to access their payslip on a monthly basis in a secure manner. As pensioners are not employee's they do not fall under the Employment Rights Act 1999 and therefore there is no requirement to provide monthly payslips.

For Pensioners without access to IT, they can of course nominate a family member or similar to access their member portal on their behalf and paper P60 will continue to be posted to any member without portal access.

#### Please find below update from Kerry McMahon-White, Head of Police Mutual

As one of our key strategic partners, I would like to share an important update with you about the next phase of growth and development for Police Mutual.

By way of background, in 2020 Police Mutual Assurance Society (PMAS) became part of the Royal London Group (RLG). Royal London ensured that Police Mutual had a more sustainable future and a stronger financial position to continue to operate as a business. At the same time, Royal London also recognised the importance of the core business relationships within the UK Police Service, as well as maintaining the Police Mutual Committee of Management, now named the Oversight Committee, for continuity and to protect the culture and ethos of the business.

When Police Mutual joined the Royal London Group, it was acknowledged that the general insurance and healthcare products sold by Police Mutual, are not central to Royal London's core business and it was always the intention to carry out a further review to ensure that the Police Mutual business could secure a long-term future with the growth prospects and investment it needs to thrive.

Royal London has announced it has reached agreement with Bspoke Group regarding the sale of the general insurance and healthcare elements of the Police and Forces Mutual businesses (Police Mutual Healthcare (PMHC) and Police Mutual General Insurance (PMGI)). It is proposed the entities will be sold together in one transaction (subject to regulatory approval).

Core to the considerations has been finding a buyer with the right strategic and cultural fit, who recognised the heritage of the businesses and its supporting of the UK Police service. On that basis, and following a robust market process, Bspoke Group has been identified as the acquiring firm.

The Bspoke Group specialises in niche affinities and specialist businesses. Their management team has shown a clear drive to continue to nurture and strengthen the relationships with our key business partners and to continue to invest in and grow the type of activity and support that Police Mutual is known for. The Bspoke Group has also confirmed they want to continue to support and harness the ethos and values of Police Mutual through financial education, wellbeing support, and the ongoing sponsorship of events, such as the Police Bravery Awards.

I am pleased to say that the current team and management structure will remain, and I will continue to lead the business. This move will bring increased opportunity and we will be in touch to discuss how we can support you in 2024 and beyond. We believe this is a positive step forward for Police Mutual and its customers and will enable us to grow and develop the products and services we offer to you and your colleagues.

Customers' and Police Mutual colleagues are expected to transfer to Bspoke in early 2024. There is no immediate change for customers and all servicing and claims will continue to be processed in the usual way.

It remains business-as-usual for the team, and I will provide updates as the sale progresses.
